### **Aquisição de ações próprias**

Nos termos e para os efeitos do disposto na alínea b) do nº 2 do artigo 11º e no artigo 13º do Regulamento da CMVM nº 5/2008, os CTT – Correios de Portugal, S.A. (“CTT” ou “Sociedade”) informam que, entre 16 e 18 de março de 2016, procederam à aquisição de ações próprias no mercado regulamentado Euronext Lisbon, nos termos detalhados adiante e em anexo ao presente:

Na sequência das referidas transações e por referência a 18 de março de 2016, os CTT são titulares de 398.827 ações próprias, compreendendo as ações agora adquiridas e as adquiridas em junho de 2015, as quais representam de 0,266% do respetivo capital social, encontrando-se os direitos de voto inerentes às mesmas suspensos por força do previsto no artigo 324º do Código das Sociedades Comerciais.

Estas transações destinam-se a satisfazer as obrigações previstas no plano de atribuição de ações a Administradores Executivos da Sociedade aprovado em Assembleia Geral, no âmbito da respetiva política de remuneração variável de longo prazo definida pela Comissão de Vencimentos, tal como oportunamente divulgado.
